 - o Government shutdown still at the forefront; very little getting done legislatively.
 - FEEA grant program paused due to low funds; given out 7K-plus, \$150 grants to date due to the shutdown.
 - 2026 COLA 2.8%/CSRS retirees; 2.0%/FERS.

 - o 4 elected positions president; VP; secretary; treasurer.
 - No VP or secretary candidates; acting president and treasurer being "held over," so no November election is needed nor December installation; volunteers still welcome.
 - o NARFE's minimum requirement for a chapter is a president and treasurer.
